Terms & Conditions Disstrikt Models

- 1. **Duration:** This is an agreement until one of both parties wishes to cancel this contract. There is a notice period involved. See the notice period below.
- 2. Notice period: The notice period is one (1) month.
 - **3. Cancellation**: The model and agency may cancel this agreement at any time. See the notice period above.
- 4A Starting date: The starting date will be directly after the mandate has been signed electronically via the payment gateway Chargebee. The model will receive immediate access to all activities in our route and can schedule them with the personal model coach.
- 4B Recurring payment date: The standard membership payment will be automatically withdrawn from the model his/her bank account on the 28th of every month.
- **4C Choose the payment date:** The model may ask for a new payment date. The model can choose between the first and twenty eight of the month. Henceforth from that day, the membership fee will be automatically withdrawn from the model his/her bank account on his/her asked date.
 - **5. Electronic Mandate:** The model will give Disstrikt their permission to withdraw money from the model his/her bank account on a recurring (monthly) basis, Until the model or agency decides to cancel the membership. Note: see article 2: "notice period".
- **6. Model events:** The model confirms that he or she knows about the events and that he/she can go for free to every event.
- 7. Model Route: The model knows about the "Disstrikt Route" and knows that there
 will be no extra charges for these activities. All these activities are included in the
 monthly membership fee.
 - 8. Personal model coach: The agency will provide a personal model coach for the model, who will guide and help him/her during the whole model route.
 - 9. Finding jobs: All modeling, acting, content creator and influencer jobs must be informed to the agency and must be credited into the publications and placements as well as being given the rights to use the pictures for the agency's own usage.
 - 10. Non-exclusive contract: Models may compete in beauty pageants and/or register and sign up for other agencies. Disstrikt will stay the mother agency of the model.
 - 11. Representation: The model will be in direct contact with workers, brands

and partners from Disstrikt Model Management. The model will meet the criteria to be on time and behave professionally. If these criteria are not met by the model, the agency may cancel this contract immediately without a notice period and/or fine the model in critical circumstances.

- 12. Contact: The model coaches will guide all models. If there are any questions from the model's side, they can always reach out to their model coach. If there are any problems with their model coach, the model can unanimously contact our management via email: contact@disstriktmodels.com
 - 13. Norms & Values model: The model will be in direct contact with other models and crew members and will treat them appropriately.
 - 14. Protection and security: The following article is published in the contracts of our partners: "The photographer, artist or other crew members will be in direct contact with the models and will treat them appropriately. This implies; that the ages of the models must be taken into consideration and that all legal and moral requirements must be met here. For any of these charges: making pornographic material or sexually abusing the models, there will be a fine for the damage that the artist caused to the model as compensation for the traumatic experience for the model in question. The final verdict and the actual fine will be pronounced by a judge and will be considered binding".

 This to make sure our models are secured.
 - 15. Photo rights: The photographers, artists, management and models may use the pictures for their own benefits. If the photos want to be published or used outside your own benefits, such as magazine publications etc. the other involved parties need to be informed and credited accordingly.
 - 16. Posts & stories: If the agency uses your pictures for their stories or feed on all social media platforms, the model and agency both promise to not speak bad about each other.
- 17. Likes & comments: From the day this contract will be signed, the agency and model both promise to help each other on social media by liking and commenting on all posts. This also included pictures that will have nothing to do with the model or agency. There is no harm, if it occurs that the agency or model misses a or several posts from each other without liking and commenting.
 - 18. Membership fee: The model knows that the membership fee will be
 automatically withdrawn every month from his/her bank account. The model
 also knows that the membership fee will be the same every month, even if the
 model would have had more than one activity or less than one activity in the
 same month.
